

**ISLAND PACKET AND SEAWARD YACHTS
TOUR LIABILITY WAIVER AND RELEASE FORM**

Island Packet and Seaward Yachts, LLC (the "Company") is an industrial company engaging in the construction of yachts and conducts, from time to time, tours of its facilities or events and functions on its premises in Clearwater, Florida, for community outreach, business development, or educational purposes (each tour, facility, or event on the Company's facilities or premises, a "Company Event"). I, the undersigned, have voluntarily requested to participate in a Company Event. In consideration of the Company's permission for my participation in a Company Event and access to the Company's facilities, I hereby acknowledge and agree to the following:

For the purposes of this Waiver and Liability Release, the Company's facilities and premises include office spaces, conference rooms, production areas, ingress and egress at buildings comprising the facilities, as well as the parking lots, sidewalks, and landscaped areas adjacent to the Company's facilities and the outdoor work areas.

The Company's facilities and premises contain, among other items, hazardous chemicals, industrial gases, power tools, heavy machinery, and other equipment that may be dangerous or harmful. Motorized vehicles are used in and around the Company's facilities by the Company's employees, consultants, agents, and contractors.

I acknowledge that there are inherent risks, dangers, and hazards to which I may be exposed in connection with my participation in a Company Event or my access to the Company's facilities or premises. I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the consultants, agents, officers, or employees of the Company, or by any other person.

My participation in a Company Event, my accessing the Company's facilities and premises and my agreement to the items above are voluntary and done with full knowledge of such risks, dangers, and hazards.

My access to the Company's facilities will be restricted. I will not be able to access any unauthorized area and will be escorted through the factory at all times.

I agree to take all safety precautions as instructed by Company employees, including the use of eye protection at all times while in production areas. I understand that breathing masks will be provided upon my request.

I understand that part of the Company Event may include going up and down stairs and will advise a representative of the Company if I feel I am unable to do so safely.

I, on behalf of myself and my heirs, voluntarily agree to release, waive, discharge, hold harmless the Company, its affiliates and its owners, consultants, agents, officers, and employees from any and all claims, actions, or losses for bodily injury, property damage, wrongful death, loss of services, or otherwise which may arise out of my participation in a Company Event or my access to the Company's facilities or premises.

I have read the above waiver and liability release, understand its terms and conditions and, by signing it, agree to the foregoing, including the waiver and release of liability.
